### Reapportionment Campaign Started In Opening Session

#### Limestone Man Gets High Post With No Opposition

MONTGOMERY, Ala., Jan. 8.—(AP)—Two legislative re-apportionment bills that would increase the House representation of Jefferson county from 7 to 3 and Mobile county from three to four and generally shift the balance of power in both houses to North Alabama, were introduced in the Senate today by Senator F. G. Stephens of the second district.

The companion measures, which also would change the line-up of senatorial districts, were introduced a short time before the Senate recessed to meet with the House to hear Governor B. M. Miller's message.

MONTGOMERY, Ala., Jan. 8.—(AP)—Alabama's quadrennial session of the state legislature convened today at high noon and within a few moments both chambers had elected presiding officers and speeded through preliminaries.

Representative Harry Walker of Athens, Ala., was named speaker of the House by acclamation, after five opponents had withdrawn.

In the senate, Senator Hardy Riddle, of Talladega, was named president pro-tem, defeating Senator Robin Swift of Brewton, 17 to 14. On motion by Swift the vote was made unanimous.

One of the two republican members of the House whose election is being contested, Norman Wilkes of DeKalb county, on roll call said he was "perfectly willing" to stand aside until the court had decided the issue. This averted any semblance of a debate on opening day.

Both Houses speeded up preliminaries to hear the message of Governor B. M. Miller who retires on January 14, in favor of Bibb Graves of Montgomery, the man whom he succeeded four years ago.
