Skottsboro leetas mīlsīga nosihme

Pat kapitalistu laikraksti sahk atsiht Skottsboro leetas mīlsigo nosihmi un pasneegt ik deenas siņas par schīs wehsturiskās prahwas gaitu, kur us apsuhdseto sola pateesībā atrodās newis 9 newainigi Negeru jauneschi, bet gan tā meschonigā, Negeru rasas masu eksploatazijas, diskriminazijas, apspeschanas un teroriseschanas sistema, kas no waldoschās schķiras teek ustureta Saw. Walstju deenwidos.

Schīs prahwas „pahrtteesaschanas” pirmajās diwās deenās, 27. un 28. martā, masajā Alabamas pilsehtinā, Decatur, ar nepilneem 10.000 eedsihwotaju, Internaz. Str. Aisstahwneeziņas (ILD.) adwokatī wehrsa neatgaimajamus usbrukumus pret Negeru pilnigu islehgshanu no teesu swehrinato saraksteem (kas ir Saw. Walstju konstituzijas pahrkahpschana).

Zaur 13 leezineeku noklausī-

schanu (no kureem 9 bij Negeri), eeskaitot kahdu laikraksta redaktoru, ka ari teesas eerehdni, kursch sastahda swehrinato listes, tika formali peerahdits, kas wišem jau bij ļoti labi sinams, ka pehdejo wairaku gadu desmitu laikā, Jackson kauntijā (kur atrodās Skottsboro) neweens Negeris nekad naw usaizinats buht par teesas swehrinato. Ais *formalo* peerahdijumu truhkuma, Saw. Walstju wirsteesa, daschās agrakās pahrsuhsdibās, bij leegusēs atsiht scho *faktu*.

Tomehr, Decatur teesnesis Hortons, bes kahdas argumentu jeb apsuhsdības puses leezineeku noklausischanās (kurai pusei nekahdu argumentu jeb leezineeku naw) atraidijis aisstahwneeziņas prasijumu isbeigt leetu us scheem pamateem.

Pee jaunās isteesaschanas swehrinato iswehles aisstahwneeziņa atkal karos pret Negeru isslehgshanu no swehrinato kandidatu saraksteem.

Jaeewehro, kā wisi jūridiskās aisstahwneeziņas soli — bes *plascha masu simpatiju un atbals-ta speedeena no ahrpuses* nespehtu gro sit waldoschās schķiras apnemschanos panahkt atkal nahwes spreedumu schinī leetā, — parahdit Negeru masam, ka „baltā” kunga wara par wiņu dsihwi-bu un nahwi joprojam paleek neeerobeschota.

Juridiskā aisstahwneeziņa, saprotams, ir pilnigi nepcezeeschama; bes wiņas newaretu konkreti registretees leelais masu speedeens no ahrpuses.

ILD. peeleeek wisas puhles preeksch masu protesta un pabalsta mobiliseschanas us wisplaschakās weenotas frontes pamateem.

Wisām apsinigo strahdneeku organisazijam wajaģa atsauktees. Patreisejā momentā naudas pabalsts ari ir no ļoti leela swara. Wajaga nekawejoschi, *neņemot paki atskaidrojam ar internaz. pabalstu.*

Dear Sir---

As a former resident of Mobile in your fair state of Alabama and as an impartial observer who always has lived within his orbit and made neither friends nor enemies; as one who always has tried to go deeper than the skin in search of truth; and as one who had gone to sea in ship for 17 years, seen many lands, met many people--- I wish to thank you for the stand you have taken in defence of Southern Soul in general, and JUSTICIA in particular.

But as words 'per se' are meaningless and deeds that count only, so I am enclosing several clippings that ought to speak for themselves and throw some light on the dark and sinister methods of Jew-York and beyond its border.

And now in view of all that permit me to state the following:
*The man under investigation, the man who brought here the 28,700 dollars for the Scottsboro Case, is no other than Albert Feierabend who was born in Latvia and came to Boston about 20 years ago. Ever since the arrival he has been, and is still connected with the so called revolutionary movement of radicals and now, the communists. During the underground activities of the communist party in Roxbury, Mass. he already occupied a prominent position. Later, when the communist party came into an open organization, he was an assistant to Robert Zelms who was secretary for the International Labor Defence of New-England with an office at 113 Dudley st. Roxbury, Mass. (Here I may add that Robert Zelms disappeared about 2-1/2 yrs ago, and, I think, went into underground activities again)

To my knowledge the said Albert Feierabend has earned but little toward his sustenance-- during the summer he would do a bit of house painting; in the winter he would go back as a seating instructor at Boston Arena.

From my personal observations, and having had a casual speaking acquaintance, I judge this Albert Feierabend to be a cunning and a resourceful person.

Among the radical elements of New-York Latvians it is an open secret that Albert Feierabend is an agent (courier) for the communist party (also the underground section) with its so called affiliate, the International Labor Defence.

It is also no secret that the man in question has made many trips abroad, each time having returned with money and secret orders from the Third International, Moscow where another agent (the editor of a Latvian semi-monthly) Arvid Brigader has been in a secret session as regards the Scottsboro Case."

This includes all I am competent to state with about 90% of certainty--- and please accept these lines as a tribute for the Souther Hospitality I received during the time of my residence in Oakdale, also Creighton, Mobile, Ala.
