WITNESSETH:

IN CONSIDERATION of the mutual covenants herein contained, the parties hereto agree for themselves, their heirs, successors and assigns, as follows:

1. The Seller will sell, and the Authority will purchase in the name of the United States of America, a tract of land situated in ~~Limestone~~ County, Alabama, described as follows:

A tract of land lying in Limestone County, State of Alabama, in Township 4 South, Range 4 West, and more particularly described as follows:

The NE 1/4 of Section 30 lying west of the west right of way line of the L. & N. Railroad Co., excepting 0.33 acres, more or less, owned by S. W. and J. D. Justice, and more particularly described as follows:

Beginning at the point of intersection of the south line of a county road with the west right of way line of the L & N Railroad Co. 16 feet south of and 812 feet west of the northeast corner of Section 30; thence north with the west right of way line of the L. & N. R. R. Co., 70 feet to a point, a corner to the land of Robert H. Walker; thence west with Robert H. Walker's line 210 feet to a point; thence north 70 feet to a point in the south line of the county road; thence east with the south line of the county road 210 feet to the point of beginning.

The above described land contains 112.7 acres, more or less, which includes one half a county road of 0.4 acres, more or less.

The NW^{1/4} of Section 30 lying west of the west right of way line of the L. & N. Railroad Co., excepting 0.33 acres, more or less, owned by A. H. and J. D. Ingles, and more particularly described as follows:

Beginning at the point of intersection of the south line of a county road with the west right of way line of the L & N Railroad Co. 15 feet south of and 612 feet west of the northeast corner of Section 30; thence north with the west right of way line of the L. & N. R. R. Co., 70 feet to a point, a corner to the land of Robert H. Walker; thence west with Robert H. Walker's line 230 feet to a point; thence north 70 feet to a point in the south line of the county road; thence east with the south line of the county road 210 feet to the point of beginning.

The above described land contains 112.7 acres, more or less, which includes one half a county road of 0.4 acres, more or less.
