My dear Harry;-

I will begin telling about my evening with William and Mamie, Saturday, we had a lovely dinner, with the most delicious fried chicken and cake for dessert, all cooked deliciously, and we had of course vegetavles then we had the fights over the Radio, that were interesting, and we had a real interesting evening, and most pleasant, I always enjoy going out for the evening, I like to know just how they are getting along, and they seem very happy together, they enjoyed your visit to the fullest, and will add I did to the last letter, only it was too brief, Memory said it did you a lot of good, so it pleased her too, was glad you could come up and see for yourself how things were progressing, for I believe Wm. make a success, it tickled me when he said to me, that he was making up his mind that he wanted to make a lot of money, he never seemed to care about that part of the things of life, but he finds it is most essential up in this neck of the woods, and I wish him every success, for I am devoted to both him and Mamie.

Bet was by here this afternoon, and told me we had to get our passports by Wednesday, so that made me think it was getting time for me to hustle a bit, so I decided to get this letter off to you this evening, and ask you just what the situation was down there, did you ask Ned about the money due me, and what is the outcome, Sara always writes like they are hard pressed, but I do not imagine that Ned manages well, but I do not think he should expect me to wait on him any longer, for am sure he does not pay Sara one sou. You said Mr. Nebrig had not paid for March or April, so May and June would make \$200.00 I should have from him, then the three months from Dave, I did not get April, and with Sara and the Kennemer's, around \$25.00 I will need ~~above that, and~~ less than \$300.00, is that asking too much, I trust you can sell the mule, or fix things up for me, but advise me immediately, for have to make the arrangements for things up here.

My addition makes that amount \$243.00 or I may have made a ~~m~~istake as to my calculations, as I am guilty of at times, and think I have more coming than I really should, but I trust I am right, I need a very few clothes, and my salary will take care of a lot of outside things that must be had. you always pay me the compliment of ^{me} saying things in such an adequate manner, that I trust this time, you are capable of seeing through the most important part and that is the urgent need of money. I will send an Itineray of my trip to Sara and one to Ada, and you can all get it from the two.

Tell Memory I enjoyed her letter to the utmost, and will answer before I sail, the third, on the Carmania, we sail at midnight, and next day is holiday, wanted that day to get together all the things I need, but I never have any surplus time allotted to me, for getting things together.

My head is about well, or at least is not so painful, but the wound is still not really well, as I told Ada my only silver lining, I did not have to pay my bills, and that would have been an item, for Doctors do not sew on you for any small amount up here, the X-rays were fifteen dollars, I do not know what the doctor's bill will be, no less than fifty am sure, and on top of that had to pay \$50.00 for a bridge tooth, but have paid thirty on that and have the rest in my purse, so will get that off my mind tomorrow.

I know you feel that I having given quite a resumé of a bank failure or something akin to it, but do not let it bother you too much, but there is one thing I know, you will not fail me.
