Yours of the 24th inst. received and just read. As it is quite plain and to the point, I feel justified in answering in like tenor.

First of all—I do not owe you one cent for rent, nor do I now owe your Mother any instalment as same has been paid in full up to Sept. 1st. For the remainder of the year I will mail you your rent check on the first of each month—in advance—and I shall expect you to be equally as kind and pay me your mother's board in advance. I have never tried to evade any honest debt I owed and I refrained from writing you as I did now ant to say what I am now going to say to you.
