Dear Mr. White:

Replying to your wire of April 26. I have been fighting for the Lee Highway for so many years that I can hardly remember when I started. I am going to do everything possible to get the same paved but we have to bare in mind that it will call for from \$1,500,000.00 to \$2,000,000.00 to complete this work. Alabama will likely get only \$10,000,000.00 for highway purposes and it is manifestly impossible to secure so large a part for one road.

I am very much in hopes that we can get the Lee Highway in Lauderdale county relocated, graded, and graveled out of the Public Works Relief funds.

Alabama will have \$2,600,000.00 of Federal funds in Washington, which must be matched by July 1, 1935. Thus giving the State an additional \$5,600,000.00 for road purposes. It is my opinion that we should get the paving in Lauderdale county next year out of this fund, as you know we cannot pave a road until it has had time to settle.
